

Because the book is intended for all states and each individual state has different laws, there may be slight differences depending on where you are. I have tried to point out common differences between states and how to ensure you know what is required in your state. Also, this is a beginnerâ™s guide. There are some very in-depth issues that most cases will likely at least touch on at some point. These in-depth issues are sometimes called âœweedsâ•. This book does not go into the weeds, which tend to be issue specific, though I do provide coaching services that can walk you through those. This book also only covers procedures at the trial court level and only through the trial. Post trial and appeal issues are very in-depth and could be the subject of their own book.
